## Minutes:

- 1. Welcome and review minutes/agenda.
  - a. October minutes approved.
- 2. Recap Board of Education presentation.
  - a. The presentation went really well, Board was impressed.
- 3. Bond/Financial update
  - a. Bond
    - i. Not a lot has changed to the Bond update since our last meeting/Board presentation.
    - ii. Ribbon Cutting ceremony for Dr. Justina Ford and Newton was on September 24.
    - iii. Received final certificate of completion for Newton on Friday, December 3, 2021.
    - iv. Junior stadium abatement is going on now, and we expect it to be completed in early 2022.
    - v. Ford still working on some exterior and interior punch list items.
      - 1. During winter break, wainscoting will be installed in the back of the stairwells and replace the secure vestibule glass.
    - vi. Franklin site
      - 1. The building is demoed. The parking lot is to be done this winter.
      - 2. Still scheduled to open on time 2022.
      - 3. Board approved the new name at the December 9 Board meeting; the new name is Gudy Gaskill.

- vii. New school on the Moody campus
  - 1. At 50% CDs (contract documents) and rapidly moving to 100% documents.
  - 2. Have competitive bids, and we are putting together our GMP (guaranteed maximum price). The current contractor estimates are coming in with about 20% escalation.
- viii. CEC (Career Exploration Center)
  - 1. DD (design development) page turn will take place on Friday, December 10.
  - 2. Travis, the principal, is currently working with his team to choose a new name which will be presented to Board in January.
  - 3. We are in good shape on this project.
- ix. Kitchen Equipment
  - 1. Lenski will be remodeled summer 2022.
- x. Security
  - 1. Secure vestibules for Centennial, Euclid, Wilder, Options, and Littleton to be substantially complete over winter break.

## b. Financial

- i. COO tasked Jacobs to look at all current and future projects and forecast a new budget number. New forecasts included escalation to reflect current market conditions. This new forecast projects \$13M over bond funding. Forecast was discussed with the CFO, and she applied a contingent to the \$13M resulting in \$14.7M added to the forecast. Jacobs will continue to update the forecast of any cost escalations and potential savings.
